River Acres is looking to build a new tank, but before they do that we needed to get our Booster Pump Station going. We did a temporary run to make sure they had plenty of water and pressure without their tank, we did those test yesterday and they are running. They will rehab their current tank, blast, and paint but they need to be down to do that. Hector received a call from Violet Water Supply, and we have discussed with them on several occasions that they would like for us to run their system. They have provided us with a checklist of what our scope of work would be, and as of right now it appears we will be providing the same service to them as we provide to River Acres. That would take us to over 6,000 connections. We would probably need two employees, a truck, and equipment. A consensus from our board is required for us to meet with their board; consensus received.

We are currently having bi-weekly progress meetings with one hydrogen plant, and the second hydrogen plant has signed a Professional Service Agreement and will be wiring \$50,000.00 which will serve as a developer payment.

We were contacted by the City of Corpus Christi for permission to cross a line on 624. We agreed.
